#### NATIONAL PROFESSIONAL CONFERENCE BURSARY POLICY

# <u>Purpose</u>

The purpose of this NPC Bursary Policy statement for AMICCUS-C is to increase accessibility opportunities for members to attend the annual NPC.

AMICCUS-C's Mission is to "offer members opportunities for learning and leadership development to fulfill and enhance their organizations".

The primary delivery mechanism in carrying out this mission is the annual National Professional Conference (NPC) hosted by AMICCUS-C. The annual three-day conference provides members with an array of opportunities to enhance their professional development through education sessions and in-person networking with peers, which in turn provides members with leadership and learning development to take back and apply in enhancing their own organizations.

AMICCUS-C has a membership base that encompasses approximately 65 student associations and unions at any given time. The membership represents a diverse mix of small, medium and large membership organizations from coast to coast. AMICCUS-C's complement of members hail from both university and college/technical environments and graduate associations and include student unions, federations, associations and councils with annual operating budgets ranging from \$1M - \$18M.

Crucial to carrying out AMICCUS-C's Mission, is offering unique and innovative ways to increase the members' ability to attend NPC events, and AMICCUS-C recognizes that financial supports to members is an appropriate mechanism to increase membership accessibility. The purpose of this Policy is to equally balance the needs of smaller sized members to send attendees to NPC and to support larger sized members to send an increased number of attendees.

The purpose of the Policy is to providing increased NPC accessibility opportunities to the entire membership in consideration of the wide range of financial capacities that are reflected in the diversity of the AMICCUS-C membership based.



## **Eligibility**

AMICCUS-C members in good standing shall be eligible to apply for the NPC Bursary. Specifically, this means that annual AMICCUS-C membership dues must be paid and upto-date by February 15 annually.

Bursaries are provided on an annual basis with a maximum of three (3) bursaries being awarded, each in the amount of \$500 (Five Hundred Dollars CDN).

Applicants must not have received the NPC Bursary within the last preceding 2 (two) years.

Applicant members will be required to submit an application in adherence to Appendix A of this Policy and clearly demonstrate how the financial support of the NPC Bursary plays a significant role in assisting with their learning and leadership development.

Bursary awards may only be applied to annual NPC registration costs and related attendance costs of NPC (such as accommodation, travel, disbursements).

Bursary awards must be used relative to the year awarded ie. NPC Bursary grant must be used for the NPC in the same year awarded.

Bursary monies will be advanced on award and only following member registration with the annual NPC host. Non-attendance at the annual NPC will require that the bursary be returned to AMICCUS-C.

#### Requirements

Bursary applicants shall direct applications directly to the Association's head office in Saskatchewan and shall include completed information as set out in Appendix A of this Policy including a declaration of compliance regarding the eligibility requirements listed in this Policy.

Deadline for applications shall be March 1. Applications must be received in Saskatchewan head office on or before March 1 annually. No late applications will be considered.

Applications by email to amiccusc@gmail.com are preferred.

Applications postmarked March 1 and submitted via postal mail to the AMICCUS-C head office will be considered eligible: AMICCUS-C, c/o NPC Bursary Adjudication Committee, PO Box 307, Silton SK SOG 4L0.



#### Adjudication Process

The AMICCUS-C Board of Directors will serve as the Adjudication Committee and as such may award a bursary annually to reach of the regions as noted in this Policy.

The Adjudication Committee's decisions on all bursary award matters are considered final.

The Adjudication Committee will select a recipient(s) based on the information provided pursuant to Appendix A in this Policy and will also consider the total number of applications received and the strength of applications.

No more than one bursary will be provided to each region annually.

No award of bursaries may be presented in a year where no acceptable applications are submitted per Appendix A of this Policy.

To ensure that a successful applicants have sufficient time to make travel plans to attend the annual NPC, the Communications Director will initiate a call for applications to the membership by January 31, with applications due by March 1 each year. The Adjudication Committee will deliberate during March and select and notify bursary recipient(s) prior to the end of March.

Information provided in the NPC Bursary applications will be kept confidential but will be reviewed by those involved in the bursary allocation process. AMICCUS-C staff may also use information provided in bursary applications to compile statistical information or research, provided that individual applicants are not identified directly or indirectly.

Member student association or student union granted a bursary must consent to the release of their names and reasons for eligibility under the criteria provided in this Policy.

#### **Review of Policy**

This Policy will be reviewed bi-annually, at minimum, by the Board of Directors, or sooner if warranted by internal or external events or changes. Regular review will ensure the Policy remains consistent with the overall objectives of AMICCUS-C.

  bursary allocation process, and that, AMICCUS-C staff may also use information
  provided in bursary applications to compile statistical information or research,
  provided that individual applicants are not identified directly or indirectly.
- Statement of agreement that if granted a bursary, consent is given to the release the name of your organization and reasons for eligibility under the criteria provided in this NPC Bursary Policy.
